

**COMMISSION REGULATION (EEC) No 2106/92**  
**of 24 July 1992**  
**fixing the import levies on frozen beef and veal**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,  
Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 805/68 of 27 June 1968 on the common organization of the market in beef and veal <sup>(1)</sup>, as last amended by Regulation (EEC) No 1628/91 <sup>(2)</sup>, and in particular Article 12 (8) thereof,

Whereas the import levies on frozen beef and veal were fixed by Commission Regulation (EEC) No 1638/92 <sup>(3)</sup>;

Whereas it follows from applying the detailed rules contained in Regulation (EEC) No 1638/92 to the quotations and other information known to the Commission

that the levies should be altered to the amounts set out in the Annex hereto,

HAS ADOPTED THIS REGULATION:

*Article 1*

The import levies on frozen beef and veal shall be as set out in the Annex hereto.

*Article 2*

This Regulation shall enter into force on 3 August 1992.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
